2. Overview

GO-TO-MARKET STRATEGY

a) Background information

b) Blockchain

The cannabis industry has already seen this type of change thanks to cryptocurrencies like Bitcoin providing an alternative to paper money.

D) Our strategy of reinvesting in the Cannabis Industry



3. OUR DEVELOPMENTS

a) Wholesaler Marketplace Dapp



- Wholesaler Marketplace Capabilities

The WID Marketplace app will feature a Wholesaler Marketplace that will allow cannabis wholesalers to sell their products directly to cannabis retailers. This will provide cannabis retailers with a convenient and easy way to purchase products from wholesalers, and it will also help reduce the costs associated with purchasing cannabis products.





- Crowdfunding Capabilities

In addition to the Wholesaler Marketplace, the WID Marketplace app will also feature a Crowdfunding capability. This will allow cannabis actors to raise money for various purposes, such as funding new product development or expanding their businesses.

- Auction of Products

The WID Marketplace app will also feature an Auction of Products capability. This will allow cannabis producers to sell their products directly to cannabis consumers.

WIDToken and WIDCoin Transactions

The WIDMarketplace app will have low fees in between WIDToken and WID Coin (Stable Coin) transactions. This will help reduce the costs associated with conducting transactions within the cannabis industry and it could work on our marketplace or integrate the payment gateway to other e-commerce related to the industry.







WID Payment Gateway has been created specifically for the cannabis industry. It can be used to pay for products and services in cannabis dispensaries and online stores. WID can also be used to pay for products and services on other websites that accept WID payment.

Our own "payment gateway" created for cannabis businesses, will allow cannabis businesses to accept payments in WIDToken and WID Coin. This would solve the problem of cannabis businesses being unable to access traditional banking services.



Payment Plugin for Shopify, WooCommerce and native developments.

Many payment gateways have been developed to support the payment of cryptocurrency, but they are generally directed at a crypto-to-FIAT function. As a result, each gateway requires specific payment functionality and generally uses custom payment form

integration on ecommerce websites – which can represent a high development cost for merchants.

The WidToken payment plugin is designed to be able to integrate with any existing themes or templates by offering a simple API interface. Therefore, the primary goal is to provide an open-source plugin that will allow ecommerce stores using different technologies (including those not based on HTML) to accept cryptocurrencies as payment options without expensive recoding or professional services requirements.

The WidToken payment gateway has been developed specifically for ecommerce stores, and will be available for Shopify store owners, WooCommerce stores and native development.

How will it work?

- The payment plugin will allow merchants to accept payment of WIDTokens at the time of checkout on their ecommerce website using blockchain technology.
- Merchants can sign up and configure accounts with WIDToken payment plugin at our payment gateway platform. There is no additional charge or cost to use this service and we take a small percentage of each transaction that is processed, our goal is to lower the cost per transaction as much as possible.
- Once configured by the merchant, buyers who purchase items on the merchant's websites will see an option to pay in WIDToken during checkout instead of other common fiat currency options such as USD or EURO. The payment gateway receives the payment in the form of WIDTokens and then forwards the equivalent value in fiat currency to the merchant bank account if needed.
- Token payments will provide a higher level of security for buyers as each purchase is verified and recorded on the blockchain. This removes the need for traditional payment card processing which can be susceptible to fraud.






- The payment gateway will also provide a simple way for buyers to store their WIDTokens in a wallet on their mobile device or computer, making it easy to use and spend with merchants who accept WIDTokens as payment.

WID Wallet App

We are working on a wallet app that will allow users to buy and sell WIDTokens and access the marketplace.

The wallet app will be available on Android and iOS devices and will provide a simple way for users to buy and sell tokens, as well as store and spend their tokens with merchants who accept WIDTokens as payment.

The wallet app will also include a built-in exchange, allowing users to exchange their WIDTokens for other popular cryptocurrencies such as Bitcoin and Ethereum.







Decentralized Supply Chain

What is a decentralized supply chain?

A decentralized supply chain refers to a system where goods are distributed through a network of independent nodes rather than a centralized authority. This type of system has many benefits, including increased security, improved transparency, and reduced costs.

How can it be used in the cannabis industry?

The cannabis industry is ideal for decentralized supply chains due to its need for secure and transparent distribution. By using a decentralized network, growers, processors, and retailers can all share information about the products they are selling, while ensuring that each step of the process is secure.

WID Coin

The price of the WIDToken is expected to rise in the future, however there may come a time that users would like an option for a more stable token.

The team has seen this need and in response created WID Coin, this coin will have small fees for transfers, speedier transactions, but with the stability of USD.

The WID Coin is a BSC20 Coin that will be launched early 2022. Users can purchase both WIDTokens and WID Coins at the same time, but they are not required to if this option does not interest them.

The Stable Coin will operate in a similar manner as Stable Coins do now, it will track USD prices for transactions done with Stable Coins. This also allows Stable Coins to be used on exchanges without any issues due to Stable Coin calculations being based on the market value.





WID Debit Card

With our new VISA debit card, members of the community will be able to spend their WIDTokens daily paying a 3% commission per transaction.



Digital Marihuana ID

We want to create a digital id for marihuana. This ID will help people avoid issues with the law and give them a more secure way of buying recreational marijuana. The marketplace will show products in which it's required to show your Marihuana ID when you get your approval in your profile.





WID Dispensaries

We are going to open WID Dispensary in Miami Florida, this will be a next generation store in which clients, producers and wholesalers will interact in our ecosystem created for the cannabis industry.

There is one primary revenue stream:



DAOs are an effective and safe way to work with like-minded folks around the globe.


